3. Have your child/student sign the YMCA's copy of this form and fill out the blue membership card.
4. Return all three portions of this application to the Welcome Center at the YMCA.
  - AA Application and Photo Release Form (Student and guardian must sign application. Only a guardian can sign Photo Release Form.
  - YMCA Membership Information (Primary Member will be the student's information. Contact information must be that of a parent or guardian.)
  - Youth COC (read and signed by the student)

### **Program Guidelines:**

- Students must use their Andre's All-Stars membership at least 4 times per month.
- If not, your student's membership may be revoked and given to another student.
- Students must keep regular attendance at school, without suspensions and achieve passing grades in all their classes.
- Students will have access to all the YMCA facilities and classes: gym, fitness center, youth center, fitness classes, pools, and locker rooms.
- I agree to follow all the YMCA policies regarding the facilities and classes.
- Students must seek out a fitness center orientation before entering/using any equipment.
- If there is a problem or issue that arises, students must communicate with the Teen Coordinator to learn what can be done to address the concern.
- Students must bring their YMCA membership card every time they visit at the Y.
- Students must attend a Teen Member Orientation (TMO) before or during their first visit.
